# Scheme for granting permits licenses to import fully electric vehicles for Sri Lankans employed abroad

Following Sections of the Ministry of Labour and Foreign Employment Circular No.02/2022 dated 31.08.2022 issued on granting permits/ licenses for the importation of fully electric motor vehicles by Sri Lankans employed abroad are hereby further amended as follows in addition to its subsequent amendment No. 02/2022 (i) dated 09.09.2022.

#### **Section 4-Conditions**

(1) Following phrase is added at the end of sub Section 4.3

"Permission is hereby granted to an agent/ authorized distributor of the manufacturer who is registered in Sri Lanka to import 3 brand new fully electric vehicles in 3 different models registered in the name of the aforesaid agent/ authorized distributor for the purpose of display and demonstration and such vehicle is unable to be transferred to another party within 5 years.
