## Scheme for Granting Permits/Licences to Import Fully Electric Vehicles by Sri Lankans **Employed Abroad**

As you may aware, the concerned period of remittances by migrant workers to be eligible for obtaining a vehicle permit under the above scheme has been extended up to 15 September 2023. As such amended period is from 01 May 2022 to 15 September 2023. To that effect, the Ministry of Labour and Foreign Employment issued the Circular No.02/2022(iv) dated 17 May 2023 as published in the Ministry of labour and Foreign Employment website.

- 2. Further, I would like to draw your kind attention to the following in relation to issuing the remittance confirmation letters by the respective bank branches.
  - 2.1) Keeping in line with the respective Cabinet Decision and the subsequently issued implementation Circular No.02/2022 dated 31.08.2022 (as amended), the Ministry of Labour and Foreign Employment introduced a specimen letter of eligible remittance confirmation. However, it is observed that few of such confirmation letters received by this Ministry is not in the prescribed format whereas some remittances included are not fallen under the category of eligible remittances as described in two tables of the specimen.
  - 2.2 When issuing permits, it should be ensured that out of total remittance, at least to CIF value of the vehicle permit has been converted into LKR. forex equivalent In some confirmation letters, it is difficult to get it confirmed.

Therefore, please make necessary internal arrangement to keep branch managers informed to adhere to specimen confirmation letter attached hereto, as updated in this Ministry website.
